EXTINGUISHING MEDIA

Class: C2 Combustible Liquid

Section 6: ACCIDENTAL RELEASE MEASURES

EMERGENCY PROCEDURES: Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. If possible contain the spill. Prevent entry into sewers, waterways, basements or confined areas. Place inert absorbent material on spillage e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. If the spillage enters the waterways contact the Environmental Protection Authority, or your local Waste Management Authority.

STORAGE: Store undercover in cool, dry place with good ventilation to avoid water contamination and fading. Products should not be stored over 60°C.
