### Section 6: ACCIDENTAL RELEASE MEASURES

Prevent entry into sewers, waterways, basements or confined areas. Place inert absorbent material on spillage e.g. sand, earth, vermiculite or diatomaceous earth and place in container for disposal according to local regulations. If the spillage enters the waterways contact the Environmental Protection Authority, or your local Waste Management Authority.
